Open Division Bout Times 1:30 - 1:30 - 1:30 with 1 minute OT and 30 second RO
Proof of age required if challenged. Challenger and challenged must present proof of age.
Wrestlers may enter multiple Divisions but must pay double fee and no minimum rest time can be guaranteed.
Wrestling Shoes Headgear Singlet or Tight Shorts and Shirt Required.
